The opening date for Released Time for Religious Instruction during the 1997-98 school year is Wednesday, September 17, 1997 for students of the Jewish faith and Wednesday, September 24, 1997 for students of the Roman Catholic faith. Such instruction will continue through Wednesday, June 3, 1998 for students of the Roman Catholic faith, and through June 24, 1998, for students of the Jewish faith **except** for:

1.1	November 26, 1997	Thanksgiving Eve	No Released Time Classes except for students of the Jewish faith.
1.2	December 24, 1997	Winter Recess	No Released Time Classes.
1.3	December 31, 1997	Winter Recess	No Released Time Classes.
1.4	February 18, 1998	Mid-Winter Recess	No Released Time Classes.
1.5	April 8, 1998	Holy Week	No Released Time Classes except for students of the Jewish faith
1.6	April 15, 1998	Spring Recess	No Released Time Classes
