

Resolution Regarding the Proposed Re-siting and Co-location of the Middle School Grades of Achievement First Apollo Charter School (84K774) to Building K292 with J.H.S. 292 Margaret S. Douglas (19K292) Beginning in the 2016-2017 School Year

WHEREAS, in accordance with Education Law § 2590-h(2-a), the Chancellor prepared an educational impact statement (“EIS”), published and filed on January 8, 2016, on the proposed re-siting and co-location of the middle school grades of Achievement First Apollo Charter School (84K774) to Building K292 with J.H.S. 292 Margaret S. Douglas (19K292) beginning in the 2016-2017 school year; and

WHEREAS, in accordance with Education Law § 2590-g(8), the Panel for Educational Policy (the “Panel”) undertook a public review process for review and comment on the proposal; and

WHEREAS, such review process included notice of the proposal via the Department of Education’s (the “Department’s”) internet website and circulation of the notice of proposal to all community superintendents, community district education councils, community boards, and school based management teams; and

WHEREAS, such notice further included: a) a description of the purpose and substance of the proposal; b) information regarding where the full text of the proposal could be obtained; c) the name, office, address, email, and telephone number of the Department representative from whom information concerning the proposal could be obtained; d) the date, time, and place of any hearing on the proposal; e) the date, time, and place of the meeting of the Panel at which the Panel was to vote on the proposal; and f) information on how to submit written or oral comments regarding the proposal; and

WHEREAS, such notice and public review process commenced on January 8, 2016, at least forty-five days in advance of the February 24, 2016 meeting of the Panel at which the proposal came before the Panel for a vote; and

WHEREAS, on January 12, 2016, the Department issued an amended EIS with accompanying Building Utilization Plan (“BUP”) for K292 which corrected typographical errors. The amended EIS and BUP reflect the correct DBN of Achievement First Apollo Charter School, which was listed incorrectly in the original EIS and BUP. Additionally, the amended EIS and BUP reflect a correction to the street address of building K292; and

WHEREAS, on February 5, 2016, the Department issued a second amended EIS and BUP which reflect that the CBO Good Shepherd had replaced the CBO Soul Tigers in K292 and is now serving students in the space previously occupied by Soul Tigers; and

WHEREAS, on February 9, 2016 and February 10, 2016, in accordance with Education Law 2590-h(2-a), the Chancellor held joint public hearings on the proposal with the District 19 Community Education Council and the school leadership teams, at which all interested parties had an opportunity to present comments or concerns on the proposal; and

WHEREAS, following the public review and comment period, the Panel made available to the public, including via the Department's internet web site, an assessment of all public comments concerning the proposal; and

WHEREAS, the assessment of public comments included a summary and analysis of the issues raised and any significant suggested alternatives; a statement of the reasons why any significant alternatives were not incorporated into the proposal; a description of any changes to the proposal as a result of the public comments; and

WHEREAS, the Chancellor recommends that the Panel approve the proposal; and

WHEREAS, it is the desire of the Panel to approve the proposal; now therefore be it

RESOLVED, that in accordance with Education Law § 2590-g, the Panel for Educational Policy hereby approves the proposed re-siting and co-location of the middle school grades of Achievement First Apollo Charter School (84K774) to Building K292 with J.H.S. 292 Margaret S. Douglas (19K292) beginning in the 2016-2017 school year.
