- Masters Degree in special education or a related service area: speech, school psychology, social work, and/or guidance.
- Trained in Applied Behavior Analysis (ABA)
- Minimum of five (5) years satisfactory experience working with students with disabilities including students with autism.
- Experience providing professional development on topics related to the education of students with disabilities including students with autism.
- Evidence of building strong relationships with colleagues, families, and community members.
- Collaborative approach to managing projects and activities.
- Knowledge of New York State laws relating to the provision of instruction and services to general and special education students, and specifically students on the autism spectrum.

DUTIES AND RESPONSIBILITIES:

Under the supervision of the Director of ASD Programs, Division of Students with Disabilities and English Language Learners, the Autism Coach will:

- Offer professional development and on site coaching to schools that have specialized programs for students with autism or who want to develop such programs.
- Provide information, professional development, and training on the referral, assessment, and provision of instruction to students on the autism spectrum.
- Provide direct coaching to teachers of students with autism included, but not limited to implementation of ABA based curriculum.
- Collaborate with contracted partners in order to provide high quality services to schools and teachers.
- Provide parent training.
- Assist with the development and execution of city-wide professional development and workshops on autism
- Participate in school level meetings with local administration and ASD Senior School Improvement Specialists (SSIS)
- Provide on-site support and coaching as requested for non ASD program schools
- Interface between ASD program schools, partner organizations and ASD SSISs
- Attend conferences, professional development, and training as required.
