¹ The current school administration just received a copy of the chartered accountability goals. The school plans to submit a letter requesting an amendment to the charter to replace two accountability measures which cover norm-referenced testing with more useful measures. The two measures we are omitting are:
 1) Each year, the academic growth rates in reading and mathematics for the students will either meet or exceed the national growth rates as evidenced by the gain in scale score points from the fall to the spring administrations of the Norm-referenced Test. And 2) Each year, the academic growth rates in reading and mathematics for the students at the Charter School will either meet or exceed the growth rates of schools with comparable demographics, as evidenced by the gain in scale score points from the fall to the spring administrations of the Norm-referenced Test.




