Request to Determine Eligibility for G&T Programs for the 2014-2015 School Year

Only parents/guardians who are current New York City residents may submit a Summer Request for Testing (RFT) form for their child to determine eligibility to apply for placement into a Gifted & Talented (G&T) program. Summer RFTs will only be accepted for children who became New York City residents **after November 8, 2013** and are entering grade K (born in 2009) or 1 (born in 2008) for the 2014-2015 school year.

The deadline to submit the Summer RFT is Friday, June 20, 2014

New to New York City

Proof that New York City residency was established after November 8, 2013 must be provided when submitting a 2014 Gifted & Talented Summer Request for Testing form. You must be able to provide documentation of your previous non-NYC address as well as your current NYC address. The following may be used as supporting documentation:

Proof of prior non-NYC residence will be verified by any two of the following:
(must be dated prior to November 8, 2013)

- Previous original lease agreement, deed or mortgage statement for your non-NYC residence
- Previous residential utility bill (gas or electric) in the resident's name.
- Letter from the school child last attended
- Report card from the child's previous school
- Relocation documentation from parent's employer

Proof of current NYC residence will be verified by any two of the following:
(must be dated within the past 60 days)

- Current original lease agreement, deed or mortgage statement for your NYC residence
- Current utility bill (gas or electric) in the resident's name issued by National Grid (formerly Keyspan), Con Edison, or the Long Island Power Authority.
- A current property tax bill or water bill (*must be dated within past 90 days*)
- Official payroll documentation from an employer, such as a form submitted for tax withholding purposes or payroll receipt
