Resolution #34

Calling for an End to the Test-Score Based Accountability System, and for the Development of a New Accountability System for Our Students, Teachers and Schools.

WHEREAS, the New York City Department of Education’s current accountability system relies predominantly (85% of the school report card) on standardized test scores in English Language Arts and Mathematics and the scores from consecutive years are used to measure “Annual Yearly Progress (AYP)”;

WHEREAS, under current Department of Education policy the standardized test scores are the primary means by which determinations on students’ grade promotion, teacher performance, and principal’s bonuses are made;

WHEREAS, the standardized tests currently in use were NOT designed to assess students' academic progress or to evaluate teacher effectiveness, and experts state that school level fluctuations in test scores are mostly random;

WHEREAS, the attempt by the NYS Department of Education in June 2010 to recalibrate test scores resulted in only 42% of students performing at or above proficiency level in ELA, down from 69% the prior year and only 54% of students performing at or above proficiency level in Math, down from 82% the prior year;

WHEREAS, under the 2010 recalibration of scores the number of students who tested in Level 1 on the ELA test increased from 12,000 to 63,000 citywide;

WHEREAS, under the 2010 recalibration of scores in 36% of elementary and middle schools at least two thirds of the students are not meeting standards in ELA;

WHEREAS, a large number of families in the City including in District 2 were led to believe their children met state standards in math and/or ELA when they did not;

WHEREAS, there is a dire and urgent need for an assessment system that truly measures our students' achievement, our teachers' performance, and our schools' quality;

WHEREAS, such an assessment system must be comprehensive and holistic and must not rely on any one particular metric as the major indicator of success;

THEREFORE BE IT RESOLVED, that the CECD2 calls upon the NYC Department of Education to immediately empower the District Superintendent to develop and implement a plan for intensive academic services for all students who scored in Level 1 and Level 2, including those now in high school;

BE IT FURTHER RESOLVED, that students throughout the system be provided with more individualized attention, including smaller classes particularly in the District's most struggling schools and a curriculum free of any direct test preparation;

BE IT FURTHER RESOLVED, that the CECD2 demand that the DOE suspend all high-stakes policy decisions that are based on standardized test scores and overhaul the current accountability system and develop a more holistic and comprehensive system that does not rely on any one particular metric, such as standardized test scores; and

BE IT FURTHER RESOLVED, that the District Superintendent be tasked with working with all stakeholders in District 2, including parents and students, to develop a comprehensive and holistic system of assessing student performance in District 2.

Calling for an Educator as New York City Schools Chancellor

WHEREAS, the Community Education Council District 2 (CECD2) strongly believes that our public school system needs a Chancellor who understands teaching and learning as well as has the ability to manage a system with more than a million students;

WHEREAS, the CECD2 believes that educating our children is fundamentally different from managing employees of a large corporation and opposes the management of our school system as if it were a corporation;

WHEREAS, the administration's previous overhauls of the education system several times created system-wide confusion and the dismantling of highly successful local school districts including District 2;

WHEREAS, the current approach to reforming the public school system in New York City has been firmly based on the corporate model of management including the emphasis on standardized test scores and grade promotion which treats our children as products, teachers as adversaries and principals as Chief Executive Officers and fails to permit our teachers to teach, our children to learn and our principals to lead;

WHEREAS, a Chancellor who does not meet the State's minimum requirements for superintendency must obtain a waiver from the New York State Education Commissioner;

WHEREAS, the current mayoral appointee for Chancellor does not meet the State's minimum requirements for superintendency and must obtain a waiver from the New York State Education Commissioner;

WHEREAS, the minimum requirements for superintendency were implemented to ensure that only suitable candidates who are fully qualified for the position be appointed as Chancellor;

THEREFORE BE IT RESOLVED, that the CECD2 urges State Education Commissioner David Steiner to deny a waiver for any mayoral appointee who does not meet the State's minimum requirements for superintendency; and

BE IT FURTHER RESOLVED, that the State Education Commissioner urge Mayor Michael Bloomberg to conduct a proper and thorough search for Chancellor and appoint a Chancellor who meets the State's minimum requirements for superintendency and is both a respected and accomplished educator.

RESOLUTION FOR: We the undersigned endorse the following Education Reform Manifesto.

COMMUNITY DISTRICT EDUCATION COUNCIL 30 *RESOLUTION #53* *OPPOSING THE DESIGNATION OF I.S. 126 AS UNDER-UTILIZED*

Whereas, the New York City Department of Education has determined that I.S. 126, The Albert Shanker School for Visual and Performing Arts, is “under-utilized”; and

Whereas, the New York City Department of Education must use existing public buildings in the most efficient manner possible; and

Whereas, the New York City Department of Education must work to ensure that students and families in every community have high-quality educational options; and

Whereas, the New York City Department of Education has made this determination based upon the 2009-2010 Capacity-Enrollment-Utilization Report (The Blue Book); and

Whereas, The Blue Book assumes that all schools and communities are equal and does not consider the diversity of needs and resources of communities; and

Whereas, The Blue Book has been consistently criticized and challenged for using inaccurate formulas which do not reflect the actual use of buildings and that do not factor in basic educational space necessities, especially rooms for supplemental services for struggling students and space for science and art labs/rooms which are especially crucial for the middle school curriculum; and

Whereas, The Blue Book does not factor in the fact that I.S. 126 houses the middle school suspension site for the entire borough of Queens, with full staff, an Assistant Principal and Principal for 3 grades which utilizes the entire first floor consisting of 8 classrooms and 3 offices; and

Whereas, The Blue Book does not consider that I.S. 126 is under construction and 3 classrooms cannot be used due to major repair projects; and

Whereas, during the past two years the new Principal has increased enrollment; and

Whereas, I.S. 126 is a School In Need of Improvement (SINI) with specific plans and programs designed to raise the achievement with intense focus on those groups not meeting AYP (Annual Yearly Progress); and

Whereas, one of the strategies the administration has implemented is to divide the school into small learning communities utilizing all available rooms; and

Whereas, the success of these programs and students in part depends upon providing adequate space to implement these programs and maintaining and lowering class size; and

Whereas, CDEC30 acknowledges that lowering class size can be an effective strategy used to promote student achievement in groups not meeting AYP; and

Whereas, the building layout does not support the sharing of spaces such as the auditorium, gymnasium and cafeteria;

Therefore Be It Resolved that Community District Education Council 30 fully supports the recommendation of the I.S. 126 School Leadership Team and that of the District 30 Community Superintendent, Dr. Philip A. Composto that I.S. 126 not be classified as an under-utilized building; and

Therefore Be It Further Resolved that Community District Education Council 30 call on the New York City Department of Education to support the I.S. 126 community's efforts to remove the school from "SINI" status by ensuring that adequate space is available to provide vital services and programs for all students; and

Therefore Be It Further Resolved, that Community District Education Council 30 call on the New York City Department of Education to remove the "under-utilized" classification and acknowledge the actual utilization percentages of I.S. 126 based on real circumstances in the building; and

Therefore Be It Further Resolved, that Community District Education Council 30 fully supports and will be an active partner in facilitating the Principal's vision for I.S. 126 to be a community school.

Whereas, immediately following Mr. Klein's announcement, New York City Mayor Michael Bloomberg announced the appointment of Catherine Black as the next New York City Public Schools Chancellor; and

Whereas, New York State Education Law Article 61, § 3003 states "*Qualifications of superintendents. 1. No person except one in possession of a valid superintendent's certificate... shall hereafter be eligible to the position of superintendent of schools...*"; and

Whereas, New York State Education Law Article 61, § 3003 further states the requirements to possess a superintendent's certificate to be "*a. He shall be a graduate of a college or university approved by the commissioner and in addition shall have completed sixty semester hours in graduate courses approved by the commissioner; and b. At the time of his appointment each shall have completed three years of teaching experience satisfactory to the commissioner in public or non-public schools.*"; and

Whereas, New York State Education Law Article 61, § 3003 further states "*3. The commissioner, at the request of a board of education or board of cooperative educational services, may provide for the issuance of a certificate as superintendent of schools to exceptionally qualified persons who do not meet all of the graduate course or teaching requirements of subdivision one of this section, but whose exceptional training and experience are the substantial equivalent of such requirements and qualify such persons for the duties of a superintendent of schools.*"; and

Whereas, while CDEC30 acknowledges that Ms. Black's business accomplishments are commendable, CDEC30 feels strongly that our children would benefit from a Chancellor with a proven record as a successful educational leader with knowledge of curriculum, and who comprehends the importance of parent and community engagement in education, and who is familiar with the challenges of leading a school community, and someone who has experience with labor negotiations and the public sector; and

Whereas, CDEC30 believes that success as an educational leader and success in management and business are not mutually exclusive, and that a public search for highly qualified internal and external candidates with exceptional leadership skills **AND** a background in education would be fruitful; and

Whereas, there was no public search for candidates, no consideration of internal candidates and no vetting or interview of the candidate;

Therefore Be It Resolved, that CDEC30 calls on Commissioner Steiner to uphold the Law requiring that the Board Of Education (Panel for Educational Policy, PEP) request the waiver, thereby insuring at the very least, a venue for public comment and a public vote; and

Therefore Be It Further Resolved, that the Board of Education (PEP) not request a waiver until the completion of a public search, interviews and public comment; and

Therefore Be It Further Resolved, that CDEC30 calls on Commissioner Steiner to uphold New York State Education Law by demanding evidence that a qualified individual satisfying the requirements of the Law is not available before considering granting a waiver.
