

## **Amended Notice of Joint Public Hearing, Educational Impact Statement and Building Utilization Plan**

### **Proposal: The Proposed Co-Location of New Visions Charter High School For the Humanities IV (84QTBD) with Jean Nuzzi Intermediate School (29Q109) in Building Q109 Beginning in the 2016-2017 School Year**

This is a proposal to open and co-locate New Visions Charter High School for the Humanities IV, a charter high school that will serve students in grades nine through twelve in building Q109 (“Q109”), with Jean Nuzzi Intermediate School, an existing district middle school that serves students in grades six through eight, beginning in the 2016-2017 school year. Q109 is located within the geographic confines of Community School District 29. A “co-location” means that two or more school organizations are located in the same building and may share common spaces, such as auditoriums, gymnasiums, libraries, and cafeterias. A Joint Public Hearing will be held for this proposal. The purpose of this hearing is to provide the public with an opportunity to present comments.

The Department of Education has amended this notice to reflect the new start time of the Joint Public Hearing. No changes have been made to this proposal.

Members of the public who wish to provide comments are encouraged to attend the hearing and share their feedback in person. Members of the public who do not provide comments at the hearing may also provide oral or written comments as described below. All comments must be submitted at least 24 hours in advance of the Panel for Educational Policy meeting at which this proposal is subject to a vote in order to be mentioned in the Public Comment Analysis to be published and provided to the Panel the evening before the Panel votes.
