1. Title IV Consortia (Agudath Israel, Archdiocese of New York & Brooklyn Diocese)

Service: The Office of Youth Development is requesting non-competitive awards to three vendors that perform the consultation services nonpublic schools receiving Title IV funding in accordance with the No Child Left Behind Act. These vendors have current contracts, approved by the Committee On Contracts in August 2004, that will expire on August 31, 2007.

The term of each agreement will be from September 1, 2007 to August 31, 2010, at a three year cost not to exceed:

2. Harcourt

Service: The Office of Accountability wishes to execute a contract with Harcourt to provide a set of assessments designed to measure students’ progress in English and Spanish language proficiency throughout the school year (ELL Assessments). Harcourt is currently providing the ELL Assessments for NYC schools (from grades 3 - 8). Results on the ELL Assessments provide an indication of student performance on the New York State English as a Second Language Achievement Test (NYSESLAT) and on the Examen de la Lectura Español (ELE). The ELL Assessments for English proficiency will be aligned with the New York State English as a Second Language (ESL) standards and the New York State ELA Standards, and the ELL Assessments for Spanish proficiency will be aligned to the New York State Native Language Standards.

These assessments will be part of a comprehensive Periodic Assessment Program that helps gather information on students’ strengths and weaknesses relative to the related New York State Standards, and measure student learning and progress over time to help inform instruction and improve student outcomes. Specifically this vendor must provide a component consisting of English Language Learners Assessment for grades 3 - 12.

The estimated dollar amount for this contract is approximately \$3.7 million to \$4 million per year for an anticipated of July 20, 2007 - July 20, 2009. This contract action began as Component #4 for the Periodic Assessment RFP. Harcourt has been the only vendor to submit a completed proposal in response to RFP and a subsequent negotiated acquisition. The attached budget submitted by Harcourt is not the final.

3. 30 Universal Prekindergarten (UPK) Vendors

The Office of Special Projects, Division of Teaching and Learning requests that contracts be executed for 30 vendors to provide Universal Prekindergarten (UPK) services in accordance with Chapter 436 of the Laws of 1997 which provides for New York State's UPK Program. NYCDOE's UPK program entitles eligible four year olds to receive two and a half hours of UPK services a day at no charge to families and operates in all five Boroughs within public and non-public school settings.

The Request for Proposals (RFP) R0051 identified eligible high-quality early childhood providers and the solicitation process closed on February 9, 2007.

Subsequently, a grant of \$62 million was awarded by NYS for additional half-day seats. Application R0217, posted on the DOE website from May 3, 2007 to May 25, 2007, sought interested vendors. Fifty-eight vendors submitted proposals to the respective UPK Offices for which they were interested in providing services, with the 30 identified herein receiving an award via this process.

The term of this agreement is from July 1, 2007 through June 30, 2010, with an option for a 2-year renewal at the discretion of the DOE. The annual contract amount is \$3,712,050.22. The following thirty (30) vendors are being proposed for awards through this exception.
