Educational Impact Statement

I. Description of the subject and purpose of the proposed item under consideration.

In the 2010-2011 school year, Middle School for Academic and Social Excellence (17K334, "MSASE"), an existing school serving grades 6-8, will be phased out of operation. MSASE is housed in school building K390 (hereinafter referred to as "K390"), located at 1224 Park Place, Brooklyn in Community School District 17 ("District 17"). MSASE is currently co-located with The School of Integrated Learning (17K354, "The School of Integrated Learning") and KIPP AMP Academy (84K357, "KIPP AMP") at K390. The 2008-2009 target utilization rate of K390 was 51%, and its target capacity was 1,509.

In the 2010-2011 school year, MSASE will begin phasing out one grade per year. Grade 6 will be eliminated in 2010-2011 and grade 7 will be eliminated in 2011-2012. MSASE will close in June 2012.

District 17 will continue to have sufficient seats to serve middle school students with the phase-out of MSASE. This proposal will allow resources currently allocated to MSASE to be repurposed and for middle school students to be served in existing high quality District 17 middle schools. Any future proposal to site another school in K390 will be addressed in a separate educational impact statement.
