**CDEC3 RESOLUTION IN OPPOSITION TO DEPARTMENT OF EDUCATION POLICY THAT
REQUIRES STUDENTS UNPAID BALANCES FROM SCHOOL LUNCHES TO BE PAID BY
SCHOOLS**

Approved by Community District Education Council 3 on February 15, 2011

WHEREAS, under New York City law, elementary and middle school students who are behind on payment for lunch and do not have their own lunch, or money to pay for lunch must be given a meal that is offered to all other students,

WHEREAS, since 2004, the NYC Department of Education has covered the full amount of unpaid lunch charges,

WHEREAS, the NYC Department of Education now seeks to require school principals to set aside school budget money from their school budgets to cover students unpaid lunch balances,

WHEREAS, efforts by school principals to recover unpaid balances from students is limited under NYC Department of Education rules,

WHEREAS, school principals and their staff are not well suited to be collection agents and should not spend time doing so;

WHEREAS, the NYC Department of Education is better suited to collect such fees,

WHEREAS, it would be grossly unfair to reduce a school's budget for unpaid lunch fees,

WHEREAS, students who pay for lunch or who are exempt from paying for lunch would see reduced services due to the improper actions of those who cannot pay or refuse to pay.

BE IT RESOLVED, That the CDEC 3 rejects any proposal to have school budgets reduced to pay for students' unpaid lunch and demands the DOE continue to cover or absorb all unpaid lunch fees

OPPOSING THE DESIGNATION OF P.S. 171 AS UNDER-UTILIZED

Whereas, the New York City Department of Education has determined that P.S. 171, The Peter G. Van Alst School, is “under-utilized”; and

Whereas, the New York City Department of Education must use existing public buildings in the most efficient manner possible; and

Whereas, the New York City Department of Education must work to ensure that students and families in every community have high-quality educational options; and

Whereas, The Blue Book does not factor in the fact that P.S. 171 was awarded part of a \$3.78 million Federal Magnet Schools Assistance Program Grant which requires the school to have seats available so that students outside its school’s attendance zone are able to apply at all grade levels; and

Whereas, the New York City Department of Education has made this determination based upon the 2009-2010 Capacity-Enrollment-Utilization Report (The Blue Book); and

Whereas, The Blue Book assumes that all schools and communities are equal and does not consider the diversity of needs and resources of communities; and

Whereas, on December 7, 2010, the Campaign for Fiscal Equity (CFE) released a study “Capacity Counts: Demonstrating the need for Adequate, Transparent Data” which details serious flaws in the New York City Department of Education’s capacity numbers; and

Whereas, New York City Comptroller John Liu is currently conducting an audit of capacity and utilization reports based on the findings of CFE; and

Whereas, on January 20, 2011, Community District Education Council 30 passed Resolution #57 calling on the Department of Education to immediately cease using the current data collection system and formula for determining school capacity and utilization and to immediately cease declaring schools under-utilized until the results of the Comptroller’s audit are available.

Therefore Be It Resolved that Community District Education Council 30 fully supports the recommendation of the P.S. 171 School Leadership Team that P.S. 171 not be designated as an under-utilized building; and

Therefore Be It Further Resolved, that Community District Education Council 30 calls on the New York City Department of Education to remove P.S. 171 from the list of “under-utilized” buildings.

Therefore Be It Resolved, any actions taken by the DOE to reconfigure building usage must incorporate meaningful consultation with the P.S. 171 school community, CDEC30 and the District 30 Superintendent, and provide a role for these stakeholders in the decision making process.

RESOLUTION #59

OPPOSING THE DESIGNATION OF I.S. 227 AS UNDER-UTILIZED

Whereas, the New York City Department of Education has determined that I.S. 227, The Louis Armstrong School, is “under-utilized”; and

Whereas, the New York City Department of Education must use existing public buildings in the most efficient manner possible; and

Whereas, the New York City Department of Education must work to ensure that students and families in every community have high-quality educational options; and

Whereas, the New York City Department of Education has made this determination based upon the 2009-2010 Capacity-Enrollment-Utilization Report (The Blue Book); and

Whereas, The Blue Book assumes that all schools and communities are equal and does not consider the diversity of needs and resources of the I.S. 227 community; and

Whereas, The Blue Book does not consider that I.S. 227 was designated a Title I school in 2009-2010 and 2010-2011 school year requiring class size to be reduced from 33 students to 30 students; and

Whereas, the I.S. 227 building layout does not support the sharing of spaces such as the auditorium, gymnasium and cafeteria; and

Whereas, The Blue Book does not consider that in order to comply with the 2003 New York State Essential Elements of Standards-Focused Middle-Level Schools and programs which states “When a population is large, (the school building) have ‘houses’ or schools-within-schools to promote a sense of family, to reduce the feeling of anonymity and isolation among students, and engender within staff, students and the community a feeling of belonging and personal identification with the school and its purposes”, I.S. 227 is divided into three small learning communities utilizing all available rooms; and

Whereas, The Blue Book does not consider the fact that during the school day I.S. 227 hosts:

A District 75 Program consisting of 16 students, 10 staff members and one Assistant Principal.

A District 75 Work/Study Job Site for six students and one job coach.

Adult ESL classes through the Queens Adult Education Office two days per week

20-25 Student Teachers and 5 Professors from Queens College collaboratively work with IS227 faculty on a daily basis, as part of a long-standing learning partnership.

Special Education & Related Service providers that are federally mandated through the Individuals with Disabilities Education Act (IDEA) to provide these mandated services to the students with special needs; and

Whereas, The Blue Book does not consider that the current seating capacity of the I.S. 227 cafeteria is currently inadequate to service the current student population, extending lunch for four lunch periods, beginning at 10:15AM and ending at 1:15PM; and

Whereas, on December 7, 2010, the Campaign for Fiscal Equity (CFE) released a study “Capacity Counts: Demonstrating the need for Adequate, Transparent Data” which details serious flaws in the New York City Department of Education’s capacity numbers; and

Whereas, New York City Comptroller John Liu is currently conducting an audit of capacity and utilization reports based on the findings of CFE; and

Whereas, on January 20, 2011, Community District Education Council 30 passed Resolution #57 calling on the Department of Education to immediately cease using the current data collection system and formula for determining school capacity and utilization and to immediately cease declaring schools under-utilized until the results of the Comptroller’s audit are available.

Therefore Be It Resolved, that Community District Education Council 30 fully supports the recommendation of the I.S. 227 School Leadership Team that I.S. 227 not be designated as an under-utilized building; and

Therefore Be It Further Resolved, that Community District Education Council 30 calls on the New York City Department of Education to remove I.S. 227 from the list of “under-utilized” buildings.

RESOLUTION #60

OPPOSING THE DESIGNATION OF P.S. 280 AS UNDER-UTILIZED

Whereas, the New York City Department of Education (DOE) has determined that P.S. 280 is “under-utilized”; and

Whereas, the DOE must use existing public buildings in the most efficient manner possible; and

Whereas, the DOE must work to ensure that students and families in every community have high-quality educational options; and

Whereas, the DOE has made this determination based upon the “footprint” formula used for the Capacity-Enrollment-Utilization Report; and

Whereas, the formula assumes that all schools and communities are equal and does not consider the diversity of needs and resources of communities; and

Whereas, the formula does not consider that P.S. 280 is a new school opened in September 2010 and that this school is being phased in one grade at a time so that for the next five years this school will need additional classrooms each year to add each grade until it is at full capacity as a K-5 school; and

Whereas, the formula does not consider that it is because of the diligence of Community District Education Council 30 (CDEC 30) that the DOE was able to secure the building specifically to help alleviate the over-crowding of the Jackson Heights community schools;

Whereas, P.S. 280 needs room to accept the overflow from neighboring schools that are operating above capacity in Jackson Heights; and

Whereas, the P.S. 280 building layout does not support the sharing of spaces such as the auditorium, gymnasium, cafeteria and bathrooms which are only accessible from narrow hallways on the second and third floors; and

Whereas, the formula does not consider that:

P.S. 280 has 23 per cent special education students and 70 per cent ELLs and needs extra classroom space to serve the needs of these children;

P.S. 280 will need 32 classrooms in 2011-2012 and all classrooms for 2012-2013 for instruction, specialized cluster positions, special services, parent and community activities and storage;

P.S. 280 is already sharing their space with the Blessed Sacrament Church, as the lease allows the church to maintain office and storage space, use of all classrooms on Saturdays and Sundays, and use of the auditorium 3 evenings per week;

P.S. 280 has a partnership with the Goodwill-Beacon Family Literacy Program providing free after school services to P.S. 280 families, which requires administrative, instructional and storage space Monday through Saturday; and

Whereas, on December 7, 2010, the Campaign for Fiscal Equity (CFE) released a study “Capacity Counts: Demonstrating the need for Adequate, Transparent Data” which details serious flaws in the New York City Department of Education’s capacity numbers; and

Whereas, New York City Comptroller John Liu is currently conducting an audit of capacity and utilization reports based on the findings of CFE; and

Whereas, on January 20, 2011, Community District Education Council 30 passed Resolution #57 calling on the Department of Education to immediately cease using the current data collection system and formula for determining school capacity and utilization and to immediately cease declaring schools under-utilized until the results of the Comptroller's audit are available.

Therefore Be It Resolved, that CDEC 30 fully supports the recommendation of the P.S. 280 School Leadership Team and that of the District 30 Community Superintendent, Dr. Philip A. Composto that P.S. 280 not be classified as an under-utilized building; and

Therefore Be It Further Resolved, that CDEC 30 call on the New York City Department of Education to remove the "under-utilized" designation and give PS 280 the chance to succeed as a new, expanding school in an overcrowded area by allowing it to fully utilize the building in which it resides; and

Therefore Be It Further Resolved, that CDEC 30 stresses that, should there be any available seats at P.S. 280 in September 2011, these seats be used to minimize the kindergarten wait lists and overflow from District 30 schools including P.S. 69, P.S. 92, P.S. 212, P.S. 148 and P.S. 149; and

Therefore Be It Further Resolved, that Community District Education Council 30 fully supports and will be an active partner in facilitating the Principal's vision for P.S. 280 to be a community school.

REGARDING THE NAME CHANGE AND UTILIZATION OF THE I.S. 230 ANNEX

Whereas, the District 30 I.S. 230 Annex which is included in the Five Year Capital Plan, is expected to open in September 2013; and Whereas, the New York City Department of Education has notified the District 30 Superintendent that the name of the I.S. 230 Annex will be changed to 297; and Whereas, the acquisition of the land for the I.S. 230 Annex was sought after for many years to be used alleviate the severe over-crowding of District 30 middle schools in the Jackson Heights community. Therefore Be It Resolved, Community District Education Council 30 expects that the Department of Education will honor the original intent of the acquisition and that the I.S. 230 Annex, soon to be 297, will be a zoned school designed to alleviate overcrowding in District 30 middle schools in the Jackson Heights community; and Therefore Be It Further Resolved, Community District Education Council 30 expects to work collaboratively with the Department of Education when deciding how to best utilize the I.S. 230 Annex (297) to best serve the District 30 Jackson Heights community.

Whereas, The Blue Book/Footprint Formula does not factor in the fact that P.S. 111 was awarded part of a \$3.78 million Federal Magnet Schools Assistance Program Grant which requires the school to have seats available so that students outside its school’s attendance zone are able to apply at all grade levels; and

Whereas, the New York City Department of Education has made this determination based upon the “Footprint” Formula and 2009-2010 Capacity-Enrollment-Utilization Report (The Blue Book); and

Whereas, The Blue Book and Footprint Formula assumes that all schools and communities are equal and does not consider the diversity of needs and resources of communities; and

Whereas, on December 7, 2010, the Campaign for Fiscal Equity (CFE) released a study “Capacity Counts: Demonstrating the need for Adequate, Transparent Data” which details serious flaws in the New York City Department of Education’s capacity numbers; and

Whereas, New York City Comptroller John Liu is currently conducting an audit of capacity and utilization reports based on the findings of CFE; and

Whereas, on January 20, 2011, Community District Education Council 30 passed Resolution #57 calling on the Department of Education to immediately cease using the current data collection system and formula for determining school capacity and utilization and to immediately cease declaring schools under-utilized until the results of the Comptroller’s audit are available.

Therefore Be It Further Resolved, that Community District Education Council 30 calls on the New York City Department of Education to remove P.S. 111 from the list of “under-utilized” buildings; and

Therefore Be It Resolved, any actions taken by the DOE to reconfigure building usage must incorporate meaningful consultation with the P.S. 111 school community, CDEC30 and the District 30 Superintendent, and provide a role for these stakeholders in the decision making process.
