**RESOLUTION #80  
IN SUPPORT OF PROVIDING CLASSROOM SPACE FOR  
DISTRICT AND CITY-WIDE MIDDLE SCHOOL GIFTED AND TALENTED PROGRAMS  
WHERE CAPACITY IS AVAILABLE**

Whereas, each year the New York City Department of Education tests students applying to kindergarten to determine their eligibility for a seat in a Gifted and Talented class; and

Whereas, the criteria for a district wide Gifted and Talented class is a score of 90<sup>th</sup> percentile and the criteria for a city-wide Gifted and Talented class is a score of 97<sup>th</sup> percentile; and

Whereas, in 2011, 4000 kindergarten applicants were deemed eligible for a district-wide Gifted and Talented class, for which there were approximately 1725 seats, and 1803 kindergarten applicants were deemed eligible for a city-wide Gifted and Talented class, for which there were approximately 300 seats available; and

Whereas, in District 30, currently there are district-wide Gifted and Talented programs in P.S. 122 Q, P.S. 150 Q, and P.S. 166 Q, and there is a city-wide Gifted and Talented program in P.S. 85 Q; and

Whereas, more than 60% of the students currently enrolled in the city-wide Gifted and Talented program at P.S. 85 Q, are residents of District 30; and

Whereas, District 30 has a history of providing, and currently provides, district-wide Gifted and Talented classes from the sixth grade through the eighth grade at P.S. 122 Q; and

Whereas, the number of the seats in the sixth grade through eighth grade at P.S. 122 Q will not be adequate to serve all of the students currently enrolled in Gifted and Talented programs in District 30; and

Whereas, The New York City Department of Education issued a press release on March 19, 2009 titled “Three New Citywide Gifted and Talented Programs Will Open in September” that said “The programs at PS 20 and PS 85 will be located in existing schools that also have general education classes. Both of these programs will open with kindergarten and first grade classes in September and expand to serve K-5 in the coming years. The Department of Education is working to identify nearby middle schools where students in these programs can continue after fifth grade.”; and

Whereas, the four city-wide Gifted and Talented schools; Anderson, NEST+M, TAG and BSI, offer sixth grade to eighth grade; and

Whereas, it is essential to provide equal access to the Gifted and Talented sixth grade to eight grade seats for the students currently enrolled in District 30 district-wide and city-wide Gifted and Talented programs, as well as those who will be eligible in the future; and

Whereas, while many District 30 schools are overcrowded, there is currently available capacity in more than one middle school in District 30.

Therefore be It Resolved, that Community District Education Council 30 calls on the New York City Department of Education to allocate additional sixth grade to eighth grade seats within District 30 to accommodate all of the district-wide Gifted and Talented students in a district-wide Gifted and Talented program and all of the P.S. 85 Q city-wide Gifted and Talented students in a city-wide Gifted and Talented program, within a middle school that has available capacity.

## **RESOLUTION #81**

### **TO OPPOSE PLACING 8 QUEENS HIGH SCHOOLS INTO “TURNAROUND”**

WHEREAS, the 8 large high Schools in Queens (Long Island City HS, WC Bryant HS, Grover Cleveland HS, Newtown HS, Richmond Hill HS, John Adams HS, August Martin HS, Flushing HS) have been targeted for “Turnaround” under a state and federal grant to service “Persistently Low Achieving” (PLA) schools in which the current school is “closed”, the name changed and the entire staff must reapply for their positions with the DOE rehiring only 50% of the current staff; and

WHEREAS, each of the schools service the diverse communities in their geographic vicinities of Long Island City, Astoria, Elmhurst, Corona, Ridgewood, Middle Village, Glendale, Richmond Hill, South Jamaica, Ozone Park, Rochdale, and Flushing as well as students from across the borough and city; and

WHEREAS, these 8 schools offer diverse successful programs meeting the needs of all the students regardless of need, disability or language proficiency; and

WHEREAS, the DOE’s High School “choice” process initially discriminates against children based on their parents’ lack of wherewithal to participate fully in the High School “choice” process; and

WHEREAS, the High School “choice” process draws students with strong parental support away from zoned high schools such as these 8, creating a population of students who, despite lacking an IEP or ELL designation, require more support to be successful, and creating, in essence, an unfunded mandate; and

WHEREAS, the resulting lower test scores are now being held against the schools which are the last harbor for students whose parents could not participate and/or successfully navigate the “choice” process; and

WHEREAS, the threat of subjecting these 8 schools to “Turnaround” is a further act of discrimination against some of our neediest students;

Whereas, the "Turnaround" process demands that a minimum of 50% of the teachers are replaced and teacher turnover is cited as a substantial negative factor in student achievement; and

WHEREAS, since September 2011 ,the DOE has partnered Education Partner Organizations (EPO's) with Grover Cleveland HS, Newtown HS, Richmond Hill HS, John Adams HS, August Martin HS where they have just begun to establish relationships; and

WHEREAS, making the decision to put these schools into “Turnaround” less than one school year after forging these partnerships results in decisions being made without test score or graduation rate data to support them; and

WHEREAS, the DOE has built their rationalization for closing schools based on data, but in ignoring the fact that they have no new data shows an act of “BAD FAITH”; and

WHEREAS, the Mayor’s campaign at closing schools rather than supporting them has been unsuccessful insofar as the student population, with all of their associated risk factors, are no better served by the replacement schools; and

WHEREAS, the DOE has failed in its' obligations to service all of our students by creating statistically needier populations but not funding their additional needs.

THEREFORE BE IT RESOLVED, that Community District Education Council 30 supports the UFT and opposes the Mayor’s attempt to place the 8 PLA Queens High Schools into “Turnaround” and calls upon the DOE to provide the additional support and funding necessary to reduce class sizes, keep experienced teachers and secure resources so that these schools can succeed and our students can receive the quality education that they deserve.

#### **RESOLUTION #82**

#### **CALLING ON NEW YORK STATE LEGISLATORS TO AMEND THE SCHOOL GOVERNANCE LAW TO GIVE COMMUNITY DISTRICT EDUCATION COUNCILS AUTHORITY OVER SCHOOL CLOSINGS AND CO-LOCATIONS**

WHEREAS, in a recent Quinnipiac poll, almost 60 percent of New Yorkers believe that that the Mayor’s takeover of our schools has been a failure; and

WHEREAS, more than four times as many New Yorkers believe that in the future, the Mayor should share power with an independent body than retain complete control over our schools (66% compared to 13%); and

WHEREAS, public schools are the lifeblood of our communities, yet Mayoral Control, as currently structured, has no checks and balances, but allows one person to determine the fate and future of every school and student in this City, irrespective of the views and input of all other stakeholders, including parents, students, teachers, and community members; and

WHEREAS, despite damaging effects on NYC students and overwhelming community opposition, the Mayor has used his unilateral power to close over 100 public schools and proposes to close more than fifty additional schools this year; and

WHEREAS, the Mayor has also pushed through many divisive co-locations which have created worse overcrowding and thereby severely undermined the quality of education our public school students receive, creating "separate and unequal" environments within their own schools and buildings; and

WHEREAS, Community District Education Councils are elected bodies of parents that, according to New York State Law, have the authority to approve or disapprove alterations in school attendance lines; and

WHEREAS, since school closings and co-locations can radically affect enrollment, it is only logical that these bodies should have the authority to approve or disapprove school closings and/or co-locations.

THEREFORE BE IT RESOLVED, that the Legislature should amend the school governance laws so that all proposals to close, phase, truncate or co-locate NYC public schools must be approved by the Community District Education Council in which the school resides; and  
THEREFORE BE IT FURTHER RESOLVED, that before taking a vote, the CDEC shall solicit advice from the affected School Leadership Team(s), the District Presidents' Council, the Chancellor's Parent Advisory Council, and the Citywide Council on Special Education and other community organizations. In the case of high schools, the district CEC shall also consider the advice of the Citywide Council on High Schools, in addition to the organizations listed above; and

THEREFORE BE IT FURTHER RESOLVED that by these means, NYC public school parents and community members shall have a voice again as to the fate of our children's public schools.

### **RESOLUTION#83**

#### **CALLING FOR THE NYC DEPARTMENT OF EDUCATION TO CLARIFY THE ROLE OF CDECs WHEN HIGH SCHOOLS UNDERGO CHANGE IN UTILIZATION, RECONFIGURATION, RE-SITING, CO-LOCATION, PHASE-OUT OR CLOSING**

WHEREAS, the eight large High Schools in Queens (Long Island City HS, WC Bryant HS, Grover Cleveland HS, Newtown HS, Richmond Hill HS, John Adams HS, August Martin HS, Flushing HS) have been targeted for "Turnaround" under a state and federal grant to service "Persistently Low Achieving" (PLA) schools in which the current school is "closed", the name changed and the entire staff must reapply for their positions with the DOE rehiring only 50% of the current staff; and

WHEREAS, according to New York State Education Law Section 2590e, the powers and duties of community district education council includes:

*"21. Hold a joint public hearing with the chancellor or deputy chancellor, or in the case of a proposed significant change in school utilization the chancellor or his or her designee, and the impacted school based management team regarding any proposed school closing or significant change in school utilization, including the phase-out, grade reconfiguration, re-siting, or co-location of schools, of any public school located within the community district pursuant to subdivision two-a of section twenty-five hundred ninety-h of this article.";* and

WHEREAS, placing a school in "Turnaround" constitutes such a change as requires a Joint Hearing; and

WHEREAS, New York State law requires that as a part of the process to place a school in "Turnaround" requires a public hearing where representatives from both the School Leadership Team (SLT) and the Community District Education Council (CDEC) are required to attend; and

WHEREAS, the Citywide Council for High Schools (CCHS) is a creation of the New York City Department of Education, not recognized by the New York State Department of Education; and

WHEREAS, the CDECs in New York City are elected by the parents of students in K-8 schools; and

WHEREAS, parents of high school students are not eligible to vote for CDEC members; and

WHEREAS, CDEC members are elected to represent parent and community interests; and  
WHEREAS, CDEC 30 has been given three business days notice that they are “required” to attend the Joint Public Hearing Concerning the closing of W C Bryant High School; and  
WHEREAS, parents, students, teachers, staff and administrators of WC Bryant High School have been led by the Department of Education to believe that the CCHS, not CDEC30, is the council responsible for representing high schools; and  
WHEREAS, because of this misrepresentation, parents, students, teachers, staff and administrators of WC Bryant High School have not been given the opportunity to share information about WC Bryant HS with CDEC 30 that would conflict with or disprove the NYC DOE’s judgment that the school belongs in “Turnaround”; and  
WHEREAS, the combination of expecting CDEC30 members, who were not elected by parents of District 30 high school students, to represent the parents of students at WC Bryant HS, and the misrepresentation that the CCHS, not CDEC30, is the body responsible for representing the parents and community in process of determining “Turnaround” status, has violated the New York State mandate process for including CDEC input in the “Turnaround” decision making process.  
THEREFORE BE IT RESOLVED, that the Community District Education Council 30 calls on the New York City Department of Education to comply with New York State law and provide properly elected CDEC representation for the parents of students of WC Bryant HS; and  
THEREFORE BE IT FURTHER RESOLVED, that CDEC30 call on the Department of Education to halt all changes to high schools that require CDEC input under New York State Law until properly elected CDEC representatives are provided for the parents of New York City’s high school students.
