School Mission Statement

Our school's Mission Statement is summed up in the acronym C.A.R.E. The staff at P.177 Q is dedicated to C-ommunicating, A-pplauding, R-earching, and E-ducating our students, staff and community. We invite parents to be part of our leadership team, PTA and parent support group meetings. As active members of our school community, they help us achieve the goals outlined in the C.E.P. Community-based instruction is one of the major venues in which students can develop job skills, communication and life skills training. We have extensive student involvement in the community and through those experiences students learn to become independent members of society. Our programs for students with autism have served as models for the rest of District 75. We also have two inclusion sites of one class each; P.S. 87 and IS 190 at Russell Sage Highschool with students are fully integrated with general education students.

Principal's Statement

This year we celebrate our 25th year in operation. We have exploded past our original parameters. The ten classes in our mini-building, are eight years old, and are devoted to our youngest students with specialized needs. Our main building contains thirty-five classes and more than fifteen program options for the three hundred and sixty students who are educated here. We have twenty-eight classes of students with autism, fourteen classes of students with cognitive and behavioral challenges, and two classes of students with conduct disorder issues. We have a variety of work-sites in and out of school and many diversified academic options.

Special Curriculum Programs

P177Q is a self-contained special education school. We educate students, ages 5-21, with autism, emotional, and behavioral challenges. There are 50 classes, with 380 students. Our programs include: ABA, TEACCH, Horticulture, vocational, and Worksite classes. We have two inclusion sites; Russell sage Highschool and P.S. 87Q middle school.

Community Support

The speech department integrates pragmatic speech in several community programs; Queens Senior Center, and Queens Garden center. NYFAC, QSAC, YAI provide services for students with autism. We are the largest site for student interns from five colleges and universities: St. John's, Queens College, Adelphi, NYAC and LIU participate in the program.

Parent/School Support

Our guidance counselors and PTA have support groups and lectures for parents and siblings. These meetings support and educate parents. The SLT is involved in the school's education plan, and strives to continue research and best practices. Our parent coordinator keeps up constant communication with all parents via newsletters, and phone calls.






Percent Fully Licensed and Permanently Assigned to This School




Percent More Than Two Years Teaching in This School




Percent More Than Five Years Teaching Anywhere

Average Days Absent








STATE AND CITY TEST RESULTS IN ENGLISH LANGUAGE ARTS (ELA)

New York State and New York City adopted new assessments in 1998-99 to measure students' achievement of new, higher standards. The City ELA test is administered to students in Grades 3,5,6, and 7 and the New York State ELA is administered to students in Grades 4 and 8. Last year, in order to facilitate comparisons of scores from 2002 through 2004, 7th grade scores were excluded for all three years since the Department of Education and its test publisher agreed that the 2002 results for 7th graders should not be used. This year, 7th grade scores are included for all three years since this report does not include 2002 results.


























