Principal's Statement

P.993Q is a Dist.75 multi-sited school comprised of 8 sites located throughout Queens. We service students with social, educational, and emotional disabilities in the areas of Autism, Mental Retardation, Emotional Disturbances, School Phobia, Learning Disabilities, Attention Deficit Disorder & Post Traumatic Stress Syndrome. Students range from the ages of 4.9-21 years of age and participate in various activities that address academic and functional life skills. P.993 has many unique characteristics that provide a mosaic of a school that houses alternate assessment and standardized testing students grades K-12. P.993 has a total student register of 401.

Special Curriculum Programs

Teachers College Collaborative & Project Teacch are incorporated into all classes. Fletcher's Place is being used as a pilot reading program. Reading intervention programs (Great Leaps; Achieve It; Summer Success and Foundations) are utilized. The AIS coach provides curriculum support & intervention to all classrooms & at risk students.

Community Support

We have established a service learning component at our H.S. Students volunteer their time at nonprofit agencies (AHRC, GOODWILL) and community sites (1-800 FLOWERS, parks dept. Participation with VESID allows our students various post school opportunities. Our HS students also operate the "Rising Star Cafe" at the Regional






Percent Fully Licensed and Permanently Assigned to This School




Percent More Than Two Years Teaching in This School




Percent More Than Five Years Teaching Anywhere

Average Days Absent








STATE AND CITY TEST RESULTS IN ENGLISH LANGUAGE ARTS (ELA)

New York State and New York City adopted new assessments in 1998-99 to measure students' achievement of new, higher standards. The City ELA test is administered to students in Grades 3,5,6, and 7 and the New York State ELA is administered to students in Grades 4 and 8. Last year, in order to facilitate comparisons of scores from 2002 through 2004, 7th grade scores were excluded for all three years since the Department of Education and its test publisher agreed that the 2002 results for 7th graders should not be used. This year, 7th grade scores are included for all three years since this report does not include 2002 results.
























