School Mission Statement

We believe: Each student has a right to be a productive, proud, participating member of school, a family, community and society. All students deserve a dignified quality of life. School is a place where students are safe, nurtured, valued and involved in opportunities and experiences that maximize their potential and lead to maximum skills of independence and enrichment. A partnership with parents is of the utmost importance. The school respects and supports parents' aspirations for their children. The school acts as a resource for parents. Students should be: literate, able to communicate choices, able to apply skills learned at school to their adult lives, able to maintain positive relationships, able to care for personal needs, and able to appreciate the arts.

Principal's Statement

This school serves 73 classes of students with the classification of autism. Language acquisition, communication, and behavioral skills are the main emphasis of instruction. Academics, technology, and the arts are infused throughout a rich curriculum. Parents are viewed as important partners in their child's education, and are offered a wide variety of workshops and programs. Staff training is current on topics pertaining to the field of autism. Students, upon completing our middle school, are offered a variety of options and programs within district 75, all with strong vocational components.

Special Curriculum Programs

Assessment portfolio available for each student, school chorus and band, "Drumline", Latin Band, musical instrument instruction, Applied Behavioral Analysis, TEACCH style classes, person centered planning, thematic instruction, classes of 6:1:1 and 8:1:1, worksites for high school, community based instruction, rich and engaging curriculum.

Community Support

High school age students at community worksites, good relationship with other schools, local businesses. Grants received: bilingual ed, Parents as Arts Partners, New Visions and Beaumont Grant, Beaumont Technology Grants, Team Up to Clean Up- Dept. of Sanitation, linkages with agencies such as AHRC, YAI and local medical institutions.






Percent Fully Licensed and Permanently Assigned to This School




Percent More Than Two Years Teaching in This School




Percent More Than Five Years Teaching Anywhere

Average Days Absent








STATE AND CITY TEST RESULTS IN ENGLISH LANGUAGE ARTS (ELA)

New York State and New York City adopted new assessments in 1998-99 to measure students' achievement of new, higher standards. The City ELA test is administered to students in Grades 3,5,6, and 7 and the New York State ELA is administered to students in Grades 4 and 8. Last year, in order to facilitate comparisons of scores from 2002 through 2004, 7th grade scores were excluded for all three years since the Department of Education and its test publisher agreed that the 2002 results for 7th graders should not be used. This year, 7th grade scores are included for all three years since this report does not include 2002 results.















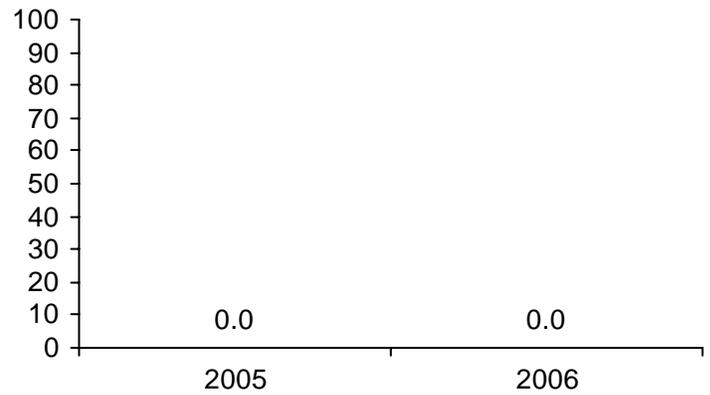











