

Student Progress represents 60% of the total score. The grade is partially based on growth percentiles, a measure of how much individual students improved on state tests in English and Math between 2012 and 2013, compared to other students in the City who started at the same level for all students and transient students. The remainder of the grade is based on placing students into the least restrictive environment where they can succeed and on changes in attendance.


