

SUBJECT: PROCEDURES FOR NYS REGENTS AND RCTs - JUNE 2008

New York State Regents and RCTs examinations have a very specific administration schedule. Tests must be administered on the date and time set by the New York State Education Department (SED). Test administration may not be started after the Uniform Statewide Admission Deadline, which is published on the SED's examination schedule. It is important for all Home Instruction Teachers, Regional Depositories, and schools to understand that the Admission Deadlines must be adhered to and that no one at either SED or in the New York City Department of Education is authorized to set them aside for any student. After the starting time of the test, Regional Depositories and schools **MUST NOT** and **WILL NOT** distribute tests. It is the responsibility of the Home Instruction teacher to arrive at the distribution center or high school with enough time to pick up the test materials and travel to the student's home, prior to the SED-scheduled starting time.

In order to arrange that Home Instruction proctors have sufficient time to travel to the student's home the following should be adhered to:

The teacher of Home Instruction must first obtain a letter signed by Sandra Ledesma, Principal of Home Instruction, which will include the student's name, ID, date of birth, and the name of the Regents and/or RCTs examination(s) that are requested. Two weeks in advance of the test date the teacher should contact a Borough Regional Depository or any NYC high school to make arrangements for obtaining a Regents examination on the day of the scheduled test date. Once the distribution-site principal approves the request scheduling can be arranged for the pick-up of test materials. The examinations should be available as early as necessary on each separate scheduled test date for distribution to proctors.

TESTS MUST BE RETURNED THE SAME DAY AS PICK-UP.

ALL IEP ACCOMMODATIONS MUST BE ADHERED TO.

The following procedures for completion of RCT answer documents are to be followed:

1. Only #2 lead pencils may be used to complete answer documents. **Do not fold or staple answer documents, and do not send them through the mail.** They must be hand delivered to the appropriate school for scoring and entering grades.
2. Regularly appointed homebound teachers are responsible for bubbling in all biographical information.
