The Annual Arts in Schools Report is a new tool for school leaders to understand their delivery of arts education to every child in their school. Each Annual Arts in Schools Report measures two areas:

Student Participation in and Access to Arts Education

Resources to Support Arts Education

Uses information from DOE databases and surveys to understand the resources that schools are allocating for arts education. Definitions

- General music is a broad-based study of music including music making, literacy, connections to world cultures, community resources and careers and life-long learning.
- A dedicated arts classroom is a classroom that is only used for dance, music, theater, and visual arts.
