New York State Guidelines and Requirements for Arts Education

The New York State Education Department (NYSED) has specific guidelines and requirements for arts instruction.

At the elementary level, in grades PreK-6, students should receive instruction in dance, music, theater, and visual arts. In addition, NYSED recommends that students spend a specific allocation of hours learning in the arts.

At the middle school level, in grades 7 and 8, the NYSED expects that students achieve, by the end of grade 8 one half-unit in dance, music, theater, or visual arts, and second half-unit in a second arts discipline.

At the high school level, the NYSED requires that all students graduate having taken at least two credits in the arts (dance, music, theater, and/or visual arts).

School's Arts Program Description

This school has submitted the following description of its arts program:
 The Marine Park Junior High Band Program has enjoyed many years of excellence. Located in Marine Park Brooklyn, students begin their musical day at 7:00 A.M. and often finish late in the evening. Students are taught their instruments from scratch in the 6th grade, and by 8th grade have several opportunities to thrive as young musicians. Marine Park's Band Program is comprised of two beginner bands, two intermediate bands, a symphonic band (audition only), two jazz ensembles (audition only), a marching band, and chorus. The symphonic band, jazz ensemble, jazz band and chorus have earned Gold and Gold with Distinction ratings at NYSSMA Festivals for the last ten years. Our Drama students are involved with two major productions each year. Our credits include Brighton Beach Memoirs, Lost in Yonkers, The Miracle Worker, Cinderella, Bye Bye Birdie, Little Shop of Horrors, Guys and Dolls, Fame Jr., and To Kill A Mockingbird.
