#### New York State Guidelines and Requirements for Arts Education

The New York State Education Department (NYSED) has specific guidelines and requirements for arts instruction.

At the elementary level, in grades PreK-6, students should receive instruction in dance, music, theater, and visual arts. In addition, NYSED recommends that students spend a specific allocation of hours learning in the arts.

At the middle school level, in grades 7 and 8, the NYSED expects that students achieve, by the end of grade 8 one half-unit in dance, music, theater, or visual arts, and second half-unit in a second arts discipline.

At the high school level, the NYSED requires that all students graduate having taken at least two credits in the arts (dance, music, theater, and/or visual arts).

### School's Arts Program Description

#### This school has submitted the following description of its arts program:

West Side Collaborative Middle School values the arts and incorporates arts into content area curriculum through interdisciplinary projects. We also offer courses in specific art forms. Students are provided with arts experiences that allow them to be creators and performers. Students explore a wide range of arts disciplines including visual, film, music, digital, dance and theater arts. In content area and arts courses, students respond to and analyze works of arts. These experiences are enhanced by long term partnerships with art museums and performing arts organizations that broaden our students' awareness of the importance of the arts and their value to society. We are pleased to continue partnerships with organizations such as the Whitney Museum of American Art, Symphony Space and The New York Historical Society to enrich our arts curricula at West Side Collaborative Middle School.
