New York State Guidelines and Requirements for Arts Education

The New York State Education Department (NYSED) has specific guidelines and requirements for arts instruction.

At the elementary level, in grades PreK-6, students should receive instruction in dance, music, theater, and visual arts. In addition, NYSED recommends that students spend a specific allocation of hours learning in the arts.

At the middle school level, in grades 7 and 8, the NYSED expects that students achieve, by the end of grade 8 one half-unit in dance, music, theater, or visual arts, and second half-unit in a second arts discipline.

At the high school level, the NYSED requires that all students graduate having taken at least two credits in the arts (dance, music, theater, and/or visual arts).

School's Arts Program Description

This school has submitted the following description of its arts program:

Our Arts programs develop creativity and technical skills. They address an essential question: How can the visual and performing arts help us envision, describe and create sustainable lives? Performing students participate in two concerts per year. All students use musical software programs, and afterschool students develop their portfolios and skills to audition for the specialized art schools. Vocalists study theory, music of diverse cultures and eras, and develop skills as soloists, in duets, trios, and large groups. Dancers develop their artistry and artistic voice, understand dance as a universal language and cultural legacy, relate dance to their life long goals, learn about professional dance careers, and build their technical skills. Visual Artists draw, paint, sculpt, compose collages and print. They critique both famous and their own art works. Interdisciplinary lessons relate the arts to academic subjects. Students submit their work to art competitions.

An IEP is the guiding document for a student's educational program. It includes all of the goals, objectives, present levels of performance and related services that are recommended for the student.
