New York State Guidelines and Requirements for Arts Education

The New York State Education Department (NYSED) has specific guidelines and requirements for arts instruction.

At the elementary level, in grades PreK-6, students should receive instruction in dance, music, theater, and visual arts. In addition, NYSED recommends that students spend a specific allocation of hours learning in the arts.

At the middle school level, in grades 7 and 8, the NYSED expects that students achieve, by the end of grade 8 one half-unit in dance, music, theater, or visual arts, and second half-unit in a second arts discipline.

At the high school level, the NYSED requires that all students graduate having taken at least two credits in the arts (dance, music, theater, and/or visual arts).

School's Arts Program Description

This school has submitted the following description of its arts program:

At IS 131, we have continued with our vision for the arts. We have established our three year program for our arts majors: Vocal, Instrumental, and Fine Arts. All students select an arts major as 6th Graders. At the end of 6th grade, those students who wish to pursue their arts education are given the opportunity to continue through 8th Grade. Our students are offered an intensive program that develops their art skills, introduces them to art history and fosters a lifelong appreciation for the arts throughout each discipline. All students are exposed to drama through ELA aligned with the CCLS. Graphic arts is incorporated within our technology program. Our staff members are available to work with any student who decides to apply to a high school that specializes in the arts by offering assistance with auditions and portfolios. We also have an Aspira After-School Program which offers dance, instrumental music, and acting programs as well as performance opportunities.
