New York State Guidelines and Requirements for Arts Education

The New York State Education Department (NYSED) has specific guidelines and requirements for arts instruction.

At the **elementary level**, in grades PreK-6, students should receive instruction in dance, music, theater, and visual arts. In addition, NYSED recommends that students spend a specific allocation of hours learning in the arts.

At the **middle school level**, in grades 7 and 8, the NYSED expects that students achieve, by the end of grade 8 one half-unit in dance, music, theater, or visual arts, and second half-unit in a second arts discipline.

At the **high school level**, the NYSED requires that all students graduate having taken at least two credits in the arts (dance, music, theater, and/or visual arts).

School's Arts Program Description

This school has submitted the following description of its arts program:

During the 2015-2016 school year, we provided a Visual Arts Cluster teacher. The students produced weekly art projects, which were hung throughout the school. The Visual Arts Cluster worked in collaboration with the classroom teachers on theme related projects and enrichment activities to enhance the Core Knowledge and Expeditionary Curriculums a Visual Arts Exhibit was presented during the Spring Fling so parents could view their children's work.

Pre-K through second grades students participated in Performing Arts Residencies.

Pre-K- First Grade experienced Folk and Fairy Tales Music and Dance and Drama/Theatre through Marquis Studios STARRS, And Music for the Many.

Marquis Studios supported the Music, Dance and Theatre experience.

Music for the Many enhanced the Music and Dance as well as Visual Arts through Pop-Up books for Kindergarten and First grade students.

The STARRS Program was selected for the Second Grade students. They worked with artists who provided Theatre and Drama along with writing coaching for the students and teachers. The students also explored 41 New York City Cultural opportunities which included: Museums to support Visual Arts, Theatres such as Lincoln Center and Carnegie Hall.

TheatrWorks presented 5 shows to expose all 766 students to a theatrical performance.

In addition to the Residencies and Arts affiliations, the students participated in Monthly Awards Assemblies where all 766 students presented twice during the school year for their peers, teachers and parents.

An IEP is the guiding document for a student's educational program. It includes all of the goals, objectives, present levels of performance and related services that are recommended for the student.
