In the 2011-2012 school year, we will begin to pilot a Response To Intervention team for grade 6. This team will work to identify student problems involving academic, social and emotional development, as well as strategies to provide improved instructional quality

Instructional strategies/activities

By June, 2012:

- We will have a 6th grade RTI team & operating procedures.
- 6th grade students will be screened for appropriate services in conjunction with their strengths and weaknesses.

- Transition our Inquiry Team into an RTI team.
- Establish a Tier II intervention plan.
- RTI team will participate in RTI professional development throughout the year and turnkey to staff.
- Create Operating Procedures.
- Establish a schedule for RTI team meetings.
- The RTI team will meet to examine data to identify students' strengths and weaknesses.
- Based on that data, students who need intervention will be determined and groups formulated.
- RTI team will examine researched based teaching strategies.
- Establish a schedule for screening procedures.
- Provide training of screening tools and interpretation of results.
- Conduct monitoring of at-risk students to inform instructional effectiveness and/or the need for changes in instruction.

Strategies to increase parental involvement

- Parents will be provided with Professional Development via a series of workshops. Targeted workshops will inform parents about RTI (Response To Intervention), what parents can do to help their children succeed.

Working in conjunction with the CFN Human Resources representative and partnerships with local teaching college programs, every effort is made to recruit and hire highly qualified teaching staff.

The services of Two ESL/ELL teachers are utilized to support and instruct our current ELL population. Additionally, These teachers are directly supported by our Literacy Coach/ESL coordinator. Additional program support is provided by Pearson specifically in the SIOP (Sheltered Instructional Observation Protocol) which all staff has been receiving ongoing professional development for the past two years.

This program is funded via Conceptual Consolidated Title I and, Tax Levy funds. Title III funds are used to support supplemental instruction before and after school.



Begin description here: Language instruction: All services are provided by the two ESL/ELL teachers using the SIOP (Sheltered Instruction Observation Protocol) model. Additional supplementary support is provided by the Discovery Education online program. This technology based program allows students to work at their own pace and reading level.

- Due to the demands the Common Core Learning Standards presents, the grade 8 ESL/ELL students receive additional services to focus on reading complex, text based material.
- ESL/ELL students receive additional afterschool instruction (two days per week Tuesday – Wednesday 3:15pm-4:05pm) from the Lead ESL/ELL/Literacy Coach. Also, due to the number of ELL's who are non English speaking and arrived this school year from another country, we are focusing on improving their English language skills. We have chosen the Milestone Curriculum/textbooks to immerse them in the English Language.
- Students receive 100 minutes of supplementary services each week (two days Tuesday/Wednesday 3:15pm – 4:05pm) during an afterschool program in small group setting.
- Instruction takes place two times per week, 50 minutes per session afterschool. Program runs from October 3, 2011 – June 20, 2012.
- Title III Supplementary services are provided by the ESL teachers during afterschool, 3:15-4:05 Tuesday/Wednesday.
- Instruction is in English.
- Students are broken into small groups based upon their individual needs. Currently, there are five students, 4 in grade 8 and one in grade 7 who are non English speaking students. Additionally, the following groups have been created: 10 students performing at the advanced level. 6 students performing at the intermediate level and 5 at the beginner level.
- These students receive additional help during the afterschool program by a Bi-Lingual Paraprofessional we have hired to assist them.
- Students scoring at the Intermediate and advanced level are provided with additional services to assist them with meeting the proficient level on the NYSES LA
