### Mission Statement

The mission of the Eagle Academy for Young Men is to develop young men committed to the pursuit of academic excellence, strong character and responsible leadership.

What sets Eagle Academy of Southeast Queens apart is our consistent commitment to the development of the whole child. We understand that every facet of childhood development, academic, social emotional, psychological, and physical are equally important to ensure their success in college and beyond. This focus on a holistic view of our students begins with the words of our mission and stems in to our 5 Pillars, Confidence, Leadership, Effort Academic Excellence and Resilience or C.L.E.A.R that filters in to every teachable moment in our school community.

Our many collaborative partnerships with community based organizations are centered in the belief that access and opportunity will narrow the achievement gap that weighs upon our society. Eagle extracurricular activities include but are not limited to; a Violin program with the Noel Pointer Foundation, Martial arts taught by DNA Karate, Robotics through a joint partnership with York College and The 100 Black Men, P.S.A.L. sports such as Basketball, Wrestling and Football, middle school CHAMPS sports in soccer, volleyball and basketball, an extensive music program by Label X, and Model United Nations in partnership with Links Inc. In addition to these in school programs we have a host of out of school program partners such as; Mount Sini, Summer Search, the All- Star Project, Eagle Foundation, Fordham University STEM program, and Sponsors for Educational Opportunity all of which are multiyear commitments to the academic and social mentoring of our young men. Each of these Community Partners assists to strengthen the habitual application of the 5 Eagle Pillars.

Another unique aspect of Eagle Academy is our "House" (advisory) program which used a developmental appropriate curriculum tailored to the needs of 11-18 year olds. Once or twice a week our young men meet in small "House" groups of 15 students or less to discuss, share, and even strategize issues that are age and interest appropriate.

As a limited unscreened program one of our ongoing challenges is meeting the diverse academic needs of our students within the confines of a small school budget. In 2013 over 90% of our incoming 6<sup>th</sup> graders were reading below grade level and 25% were IEP students. However, we have been able to make progress in closing the city and nationwide achievement gap that cripples our country. In Spring 2014 we demonstrated excellent growth on 6 and 7<sup>th</sup> grade math, 8th grade ELA and 9<sup>th</sup> grade Living Environment standardized state examinations. This year as we seek to build upon last year's progress we are focused on Math conceptual development, rigorous learning tasks across all disciplines and credit accumulation across our High school.

We developed this goal based upon a review of the 2014-2015 NYS Math assessment and the 2014- 2015 Progress report. The data showed that 14% of our students are performing at or above grade level therefore we have a school wide need for intervention and remediation of common core math skills.

By January 15, 2015 85% of students will complete the diagnostic and at least 1 lesson. By March 7, 2015 85 % of all students will complete at least 12 lessons. By April 21, 2015 85% of 6-8 grade students will complete at least 25 lessons.

A Review of the 2014-2015 progress report showed that our weakest area of school progress as compared to other schools is the English median adjusted growth percentile for our school’s lowest third. This highlighted the need to pay special attention to our most at risk readers, most of whom already have IEP’s and receive intervention services.

**<sup>1</sup>Explanation/Background:**

**At Eagle Academy, Ells are identified several ways by our school staff. At the initial registration, our school office staff has been**

trained to ask whether or not the student and /or parents speak a language other than English at home. If so, the parents/guardians are given a Home Language Survey in translation if needed to fill out immediately by the special education teacher. While the parent is completing the HLIS, the special education teacher conduct the interview with the parent(s) /and or student. The Spanish teacher acts as a translator for the special education teacher. If a student is determined to be a potential ELL by the results of the Home Language Survey and the parent/student interview(s), the LAB-R exam is administered within the first ten days of their attendance by the special education teacher. Those students who score below proficiency level on the LAB-R are flagged for ESL services. Spanish speakers who score below the proficiency level are also given the Spanish LAB-R by the Spanish teacher.

Every year, the New York State English as a Second Language Achievement Test (NYSESLAT) is given to all ELLs. Eligibility for the NYSESLAT is determined by using the RLAT report from ATS. Their scores are used to measure their individual progress and are used by the content-area teachers to inform instruction. Letters are sent home to the parents of the NYSESLAT eligible students informing them in both English and their heritage language of the importance of the NYSESLAT.

2. After all potential ELLs have been identified and tested, the parents of the resulting eligible students are invited to attend a Parent Orientation which is held within the first weeks of the school year. The parent orientation meeting is held in a designated area such as the library, teacher's resource center or large classroom. After signing in, all participants are given an agenda listing the meetings schedule of events and the speakers. The agenda is provided in all languages provided by the Department of Education. The Principal, Assistant Principal and the ESL team attends the meeting and speak about the school's welcoming culture, instructional plans and internal support systems, expectations for parents and students and the PTA schedule. The informative orientation for parents video for parents of English Language Learners from the EPIC case is played for parents in the language of their choice. After which, the available choice of language programs are discussed at length with all parents.

3. The Special Education teacher uses the updated lists of new students collected and potential ELLs identified through the school staff to compile roster of new students. Those parents who missed the orientation meeting will be given information in a phone conference and native language support is offered at every opportunity.

4. During the parent orientation meeting and subsequent phone conference, maintenance and continual development of their native language is encouraged and the benefits, both academic and cultural, are explained.

5. Our school currently offers a freestanding ESL program. The Parent Survey and Program selection forms were reviewed and it was discovered that all parents chose ESL as their program choice.

  - 1a. ESL classes are self contained and students are programmed for them by both proficiency level and grade level. ESL In addition to the self contained ESL classes, two masters teachers are pushing into content areas for ELLS. This work includes both common planning time and co-teaching
  - 1b. Again students are programmed foe ESL classes by proficiency level and grade. In cases if students are demonstrating ability in class and not aligned with his proficiency level individualized programming will occur. For example: if an intermediate ninth grade student is struggling in the double period class, based on the teacher recommendation we might move him to the double period of beginning level class.
  - 2b. All ELLs receive more than the minimum mandated minutes of instruction in ESL according to the CR part 154. Beginners at Eagle will receive a total of 675 minutes divided into a double period class and a single period class. Intermediate ELLs receive 450 minutes a week either in the form of a double period class.
  3. Beginner and intermediate ELLs, and former Ells are still eligible for support. They will receive sheltered content area classes in a Spanish/English model. The student proficiency abilities determine the percentage of instruction in each language and therefore are a good deal of differentiation is employed.

4. Spanish speaking students are administered the Spanish LAB as part of the in-take process.

5. In addition, Eagle Academy will ask the students for a writing sample in both their native language and English. If the sample leads us to suspect that there are literacy or learning difficulties we follow up using school staff who speak the home language or the Department of Education hotline in order to assure that students with additional needs receive additional services.

6. SIFE students are served by the Freestanding ESL and TBE programs and receive additional services through the Office of English Language Learners (OELL) SIFE grant. These services include peer tutoring, Saturday and afterschool native language and ESL support. Ninth grade incoming students are programmed into a team –taught section of Living Environment. Instructional tutoring is available to all students throughout the day.

6b. Newcomers present a particular challenge at the high school level because while students need to learn communicative English and basic vocabulary, at the same time they need to be doing grade level work in their content area class in order to stay on track for graduation. To meet this challenge we will try to infuse the ESL class with content strategies while at the same time providing multiple scaffolds and supports in the content classes.

6c. There are no ELL students proficient in reading and writing. This points to the need for explicit instruction around reading and writing strategies. This year we implemented the Read 180 program and incorporated writing across ELA, Social Studies, and Science content areas.

6d. The most common reason for students to be in the long term ELL category is that they are not reading and writing on grade level in English. This data has led the department to adopt three specific literary strategies for the school year. (Main idea, Evidence, Analysis, Link) paragraphs.

7. Instructional materials include Milestones, Rigor in the ESL classroom. Contents teachers are provided with grade level appropriate supports such as content materials either written specifically for ELLs.

8. As mentioned previously, we have both Spanish and sheltered English content courses available to ELLs. Our goal is to move every ELL towards graduation and college-readiness so that the intervention and targeted teaching strategies vary from class to class as appropriate. We have the two masters teacher team teaching classes where our students have the least success in Regent exams. After school, and Saturday Academy programs will offer additional support to students in these areas.


