Sports and Arts work closely with approximately 30 freshman and provide tutoring, dance, and physical education. Finally, the Queens Library for Teens will support academic achievement by offering Regents preparation assistance and events that will help our students become college and career ready.

Our strengths include structures for a positive learning environment, an inclusive culture, and a focus on student success. Also, our school-level theory of action and goals shared by the school community creates an environment in which all stakeholders are involved. Finally, we align our use of resources to support instructional goals that meet students' needs.

Areas of Focus & Challenges:

Our areas of focus and challenges include perfecting our curricula and assessment planning to align with the Common Core Learning Standards. We are also striving to implement research-based, effective instruction that yields high quality student work. Finally, we aim to provide rigorous, engaging and coherent curricula aligned to the Common Core Learning Standards.

We have grown in Tenet 5, Student Social and Emotional Developmental Health, since a positive learning environment and inclusive culture is one of our strengths. Every student at FDA VI High School understands that s/he can speak with an adult anytime on any matter and such matters will be addressed immediately.

Collectively, we have developed systems and practices to address these areas.</p> <p><i><u>Rigorous Instruction/ Tenet 3: Curriculum Development and Support</u></i></p> <p><i>Excerpts from our most recent quality review capture our strength in this tenet:</i></p>

- School leaders structure the schedule effectively to integrate teacher teams as part of its school improvement efforts via weekly meetings leading to discussions around instructional practices and review of student work. All teachers are actively engaged in structured teams by grade and department using the Looking at Student Work Protocol (LASW) to analyze student work, leading to providing supplemental practices for diverse learners. For example, during an inquiry team meeting, teachers used the LASW to analyze and provide instructional strategies to support teacher practice and student improvement in writing essays. At another teacher team meeting, teachers discussed a struggling student and determined an alternative program and guidance strategies to further his engagement in academic tasks. As a result of these structures and conscious efforts to focus on instructional work, instructional capacity has expanded to strengthen teacher practice to improve student learning.

- School leaders and staff are in the process of developing curriculum maps and lesson plans to fully integrate the CCLS and instructional shifts. Currently, staff members utilize units of study from sites such as Engage NY. Lesson plans reflect planning to provide some exposure to learning tasks that lead students to rigorous thinking.

- Some lesson plans reflect strategies to provide students some access to learning tasks. Within these planned activities are included the use of mixed level grouping for language and learning purposes, and scaffolded questioning strategies.

*Excerpts from our most recent alternate quality review and state recommendations report capture our **area of need** in this tenet:*

- Use daily and weekly meeting periods to collaborate in examining and revising coherent CCLS-aligned curriculum unit plans to ensure that the CCLS instructional shifts are incorporated in all subject areas. Collaboratively develop, share, and use CCLS aligned lesson plans in all content areas with a focus on higher-order questioning and discussion, and multiple points of entry to engage all students in higher-order thinking and analysis of information (sub statement 3.3).

- The school has yet to fully adapt all curriculum materials to reflect the instructional shifts embedded in the CCLS and content standards into school wide instructional maps. For example, a review of curriculum materials such as unit of study maps and corresponding lesson plans, demonstrate lack of full alignment and integration of higher order learning tasks reflective of the instructional shifts. Therefore, the school's ability to provide coherent rigorous instruction in all classrooms is hindered.

- The school's curricula and lesson plans are not fully refined to reflect full access for diverse learners across subject areas. For example, of all the curricula examined, only the Engage NY math curriculum for Integrated Algebra contained scaffolding boxes with suggestions of strategies for teachers to utilize to in order to provide diverse learners access to rigorous learning tasks. As a result of the absence in this refinement of units, all students miss out on being engaged in the work.

Our priority need for this school year for rigorous instruction is to align curricular materials (units/lessons/tasks) to the Common Core Learning Standards.

¹Explanation/Background:

The focus is to enhance their listening, reading and writing skills (based on NYSESLAT scores). These funds will be used to support ELL students (all students including all levels: beginners, intermediate and advanced) assigning a certified ESL Teacher in p.m. school on Mondays and Wednesdays from 3 to 5 p.m. The ESL teacher will "push-in" one hour in ELA and one hour in the Math class. The program will begin on December 10, 2014 and continue until June 15, 2015 for a total of 41 sessions. The program will be taught by a certified ESL, Math and ELA teacher. Classroom planning will occur one hour per week per subject at no cost to the program. The program will be structured as follows:

1- students will be divided into two groups of 21 students

2- the ESL teacher will spend one hour in each class every Monday & Wednesday

A certified pedagogy meets with the parent and administers the HLIS and interviews parents in English and native language. A certified ESL teacher reviews the HLIS. If the HLIS and interview indicates another language is spoken at home then the child is scheduled for the LAB-R. The LAB-R is hand scored and if the LAB-R scores indicates that student is an ELL – scores at B, I, or A level- the parent is notified and invited to a mandated parent orientation. If the student's native language is in Spanish the Spanish Lab is also administered. During the orientation the parent views a video which explains all the ELL programs that are available in the city of New York – Free standing ESL, Transitional Bilingual Education, and Dual Language. The school ensures that someone who speaks the parent’s language is present to answer all the parent’s questions. If there is no one in the school who speaks the parent’s language then someone from Translation and Interpretation Unit is contacted by phone. If the program that the parent chooses is not available in our school, the parents are informed of his/her right to transfer the child to another school where the program of their choice is offered. We inform parents that if we reach the requisite number of students needed to create a selected program, parents will receive phone calls informing them that the program will commence. We also keep track of parents who choose translation. This process is conducted within ten days of the date of admission.

At the end of the orientation parent complete the Orientation Survey and Program Selection Form. Parents are also informed that the school keeps track of the number of parents who selected the program and as soon as the school gets enough students to open the program the school is willing to do so and will contact the parents. Vocabulary and grammar are emphasized in each lesson and lessons are differentiated based on the student's performance levels. After a student tests proficient, they continue to receive modified testing accommodations.

As per the subcategories, instruction is differentiated for ELL as follows:

a.) SIFE students – If possible, content is taught in their L1 while the student takes ESL classes. The teacher will inform the students that tutoring is available for them. Spanish is the predominant language of our students. A large portion of our faculty speaks Spanish and lessons are differentiated accordingly. We also, incorporate interactive activities and questions that the reader comes up with.

b.) In all ESL classes, instruction is differentiated. Lessons coincide and foster: speaking, listening, writing, and reading. As per the remaining subgroups, we infuse, “direct instruction with specific reading strategies with interactive lessons” (<http://www.p12.nysed.gov/biling/docs/NYSEDSIFEGuidelines.pdf>) Long-term ELLs are looked at individually and lessons are tailored to meet their language needs.

Teacher of SWDs and ELLs collaborate to plan lessons. Inquiry teams will conduct a school-wide PD plan to help content teachers continue to support ELLs reaching proficiency. The focus will be on the data-driven classroom and differentiation of instruction. Teachers are trained in analyzing data and developing individual learning goals for the students in their classes. Teachers of ELL-SWDs modify materials in classroom by scaffolding text, using graphic organizers. ELLs who still require additional support may also remain in the free-standing ENL class.

The teacher will provide the student with work that correlates with their lives outside of academia. This will help the student form a connection to the content being taught in their lessons as it is relevant to their life. For example, a lesson being taught to a student who is twenty years old may incorporate life skills such as job applications. While the same content of the lesson can be taught to a ninth grader differently.

9. How does your school use curricular, instructional, and scheduling flexibility to enable ELL-SWDs to achieve their IEP goals and attain English proficiency within the least restrictive environment?

These students are programmed first. They look at the IEP to see what their needs are. Examine their NYSESLAT and LABR results to see their English proficiency level, based on their needs. Program the beginners and intermediates during their ELA periods.

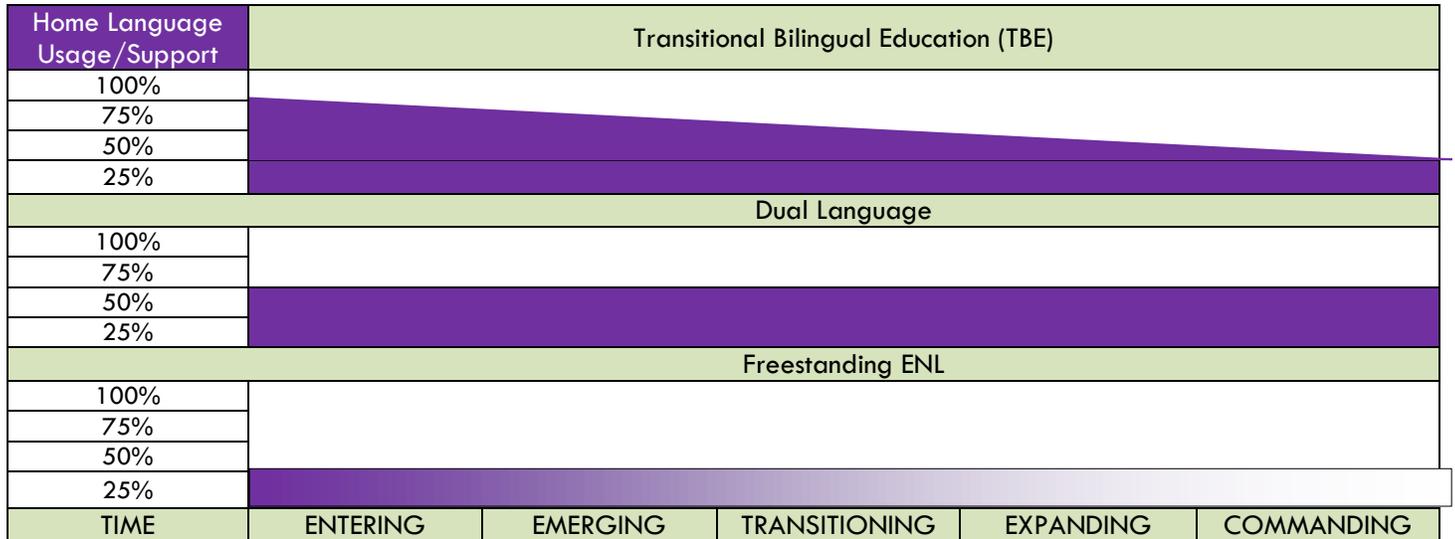
