SUBJECT: EXEMPLARY ARTS EDUCATION GRANT AWARDS

Schools designated as Exemplary Arts Education sites have been awarded \$3,000 grants. A memorandum from the Office of Arts Education (OAE), dated November 10, 2003, encouraged schools to apply for these grants. Schools selected by that office, along with their allocation, are listed on the attached table. Allotments were placed in school Galaxy budgets on March 19th. ROCs received email notification at that time.

Allocations are intended to support and enhance the existing arts program. Exemplary Arts Education schools will host groups of educators to share best practices in teaching and learning in the discipline for which they have been chosen. A grant of \$12,000 is expected to be awarded to each school in FY05, contingent upon availability of funding.
