RE: The 2016 New York City Commencement Examination in Visual Arts for High School Seniors

The NYC Commencement Examination in Visual Arts, a **closed** exam, is the culminating assessment for the high school major art sequence. It will be administered during Regents Week, on June 14th from 1:15PM to 4:15PM. Except for the student portfolio and reflective essay, all student work is graded centrally. This examination aligns with the *Blueprint for Teaching and Learning in Visual Arts*. The exam is administered to high school seniors only.

NOTE: Commencement Exam Order Form and Instructions for Completing Exam Order Form will be available at <http://schools.nyc.gov/offices/teachlearn/arts/blueprints/visual-arts-assessments.html> in early April and orders may be placed between April 11th and May 6th.

ELIGIBILITY

High school seniors who have completed **at least 10 credits** in Visual Arts coded coursework – or 9 credits if they have at least 1 credit in foreign language* – may sit for the examination. If successful they will receive the **Chancellor's Endorsed Diploma in the Arts: Visual Arts** from the Office of Arts and Special Projects upon graduation.

High school seniors who have completed **at least 6 credits** of Visual Arts coded coursework also may take this exam. If successful they will receive a **Certificate of Arts Achievement** from the Office of Arts and Special Projects upon graduation.

In both cases recognition may be placed on students' transcripts.

Attachments B and D are to be given to students by March 28th so they may prepare their portfolios and write their reflective essays **before the exam**. The scores for the portfolios and the reflective essays are due to the Office of Arts and Special Projects no later than **June 3, 2016**. Schools will be sent an Excel spreadsheet to enter the data.

EXAMINATION FORMAT

PART I - ART CONCEPTS: Design, Materials & Techniques, Cultural & Historical Connections - 30 points

Answer ALL 60 multiple choice questions

Print out the sample examination and refer to it as you read the following information regarding the Art Concepts section of the exam. The exam may be found [HERE](#).

Each work of art referenced in **Art Concepts** is used as a stimulus to ask design, technique, historical and contextual questions. Students should be familiar with the glossary in the *Blueprint for Teaching and Learning in Visual Arts*. They also should be aware of the chronological order of major art movements. Completing this section successfully does not rely upon students' detailed knowledge of art history (i.e. identifying artists and dates).

As an example of the scope of Art Concepts, images used in this section may be selected from but are not limited to the following art historical periods:

Ancient Egypt, Greece, Rome
Pre-Columbian
Renaissance

Impressionism
20th Century
Contemporary

In addition, works of art referenced in **Art Concepts** may be selected from a broad range of geographic and ethnic areas.

PART II - ESSAY: ANALYSIS AND INTERPRETATION - 15 Points

An essay response based on a given premise, and on selected works of art included in the examination booklet.

PART III - PERFORMANCE APPLICATIONS - 25 Points

- A. Two Dimensional Applied Design: a design application using a color medium (10 Points)
- B. Drawing from Observation: a drawing from observation using a black and white medium (15 Points)

PART IV – PORTFOLIO: AREA(S) OF SPECIALIZATION - 30 Points (DUE PRIOR TO THE EXAMINATION)

NOTE: Part A and Part B must be completed before the examination. The Testing Coordinator will be emailed an Excel spreadsheet to enter these scores to be returned **no later than June 3rd**.

A. Presentation of Artwork (20 Points)

An evaluation of five student artworks demonstrating mastery in 1, 2 or 3 areas of specialization. Areas of specialization include *but are not limited to*:

Architecture	Photography	Two-Dimensional Applied Design/Graphic Design
Ceramics	Printmaking	Fashion /Textile Design
Drawing	Sculpture	Media Technology
Painting	Video	Stage Design

B. Reflective Essay (10 Points)

An essay response based on the artwork in the student's portfolio

EXAMINATION ADMINISTRATION

Ordering

Schools may order exams between April 11th and May 6th. The order form will be emailed to the Testing Coordinator as an attachment.

Grading of Part IV at Schools

Portfolio attachments must be distributed to students as soon as possible so they may prepare their portfolios and write their reflective essays *before the exam*:

- B. Portfolio: Area(s) of Specialization A. Presentation of Artwork
- D. Portfolio: Area(s) of Specialization B. Reflective Essay

Part IV A and B should be graded by a pair of visual arts teachers prior to the examination. The Testing Coordinator will be emailed an Excel spreadsheet to enter these scores to be returned **no later than June 3rd**. Portfolios must be returned to students.

On Day of Exam

Test is to be administered, where possible, in an art studio. Art materials including drawing pencils, conté crayons, color pencils, markers, 9" x 12" paper and scrap paper must be available in the examination room.

With the exception of the students' portfolios and their reflective essays, this examination is scored centrally. **Immediately** after the exam **ALL** booklets, **used and unused**, must be returned to:



The original answer sheets, essays, and on-demand artwork will be securely stored for at least two years at Central. The reflective essays graded at the school must be kept for at least two years.
